

CONTRACT BETWEEN INDIVIDUAL AND DISTRICT FOR TRANSPORTING A STUDENT IN PERSONAL VEHICLE

I _____, the parent/guardian of _____, agree to provide transportation in my privately owned vehicle. Specifically, I agree to provide transportation to and from [_____] beginning on the __ day of _____, 20__ and ending on the __ day of _____ 20__.

I represent that I am properly licensed and will provide a copy of my license to the District upon request. I agree to remain properly licensed during the length of this contract.

I represent that I have liability insurance in the amount required by state law. I agree to provide a copy of proof of insurance to the District upon request. I agree to maintain liability insurance in the amount required by state law for the duration of this contract.

I represent that my vehicle is properly licensed for operation in the state of Missouri. I further represent that my vehicle has passed inspection as required by applicable state law. I further represent that my vehicle is safe in condition.

I agree that the number of passengers, including the driver, in the vehicle during the aforementioned transportation shall not exceed the number of operational seatbelts in the vehicle.

I agree that I, the driver, and each passenger shall be properly secured with the appropriate seat restraint at all times while the vehicle is in motion.

Acknowledgement of Personal Liability and Release of Liability

I hereby waive any damages and/or harm resulting to my child from my transportation of my child to/from [_____] or from my operation of a motor vehicle to transport my child to/from [_____].

By signing this form, I hereby release the Columbia School District No. 93, its Board, its Board members, administrators, directors, officers, teachers, employees, assigns, and volunteers (the "Released Parties") from and against any and all claims, demands, actions, complaints, suits or other forms of liability that any of them may sustain arising out of or in any way related to any damage or injury caused to my child by my transportation of my child to/from [_____] or by my operation of a motor vehicle to transport my child to/from [_____] (the "Released Claims").

I also agree to indemnify and hold harmless the Released Parties from the Released Claims, including any and all related costs, attorney fees, liabilities, settlements, and/or judgments.
